### BENEFITS OF MEMBERSHIP

#### Corp/Institutional Membership -

Corporations, foundations, educational institutions, government agencies, trade groups, and other organizations supporting the environmental profession and have one or more employees or principals who meet the requirements of General Membership can receive the following:
